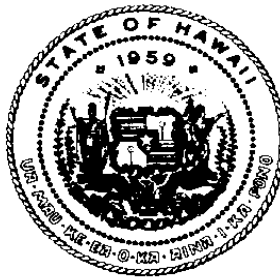

This copy of the HAWAII BRAND BOOK SUPPLEMENT 2011 lists brands registered from June 7, 2011 until December 31, 2011.














