# Attachment to Board of Agriculture May 31, 2016 Meeting Agenda V.C.3

Summary of Proposed Amendments to Chapter 4-72, Hawaii Administrative Rules (HAR), the Hawaii Department of Agriculture's Plant and Non-Domestic Animal Quarantine, Plant Intrastate Rules, Relating to Regulating Movement of Plants, Generally, and Soil

Amendment to Chapter 4-72, HAR, is proposed to add a new rule section entitled "Quarantine restrictions on ohia and soil from rapid ohia death infested areas." Rapid Ohia Death is a fungal disease that is killing ohia trees and is spreading on the island of Hawaii. The proposed permanent rule would replace Hawaii Department of Agriculture Plant Quarantine Interim Rule 15-1, approved August 25, 2015.

The proposed rule will designate the island of Hawaii as a Rapid Ohia Death infested area and will establish a quarantine to prohibit the intrastate movement of *Metrosideros* (all species in genus) (ohia) plants and plant parts, including flowers, leaves, seeds stems, twigs, cuttings, wood, logs, mulch, greenwaste, frass, and soil from the island of Hawaii to non-infested islands of the State, except by permit issued by the Department and subject to conditions consistent with preserving the quarantine, including science-based testing and, if appropriate, treatment.

The proposed rule, among other things: (1) describes the conditions under which the regulated material may qualify for intrastate shipment, including testing to determine whether the material or commodity is free of *C. fimbriata*, the causal fungus of the disease; (2) prohibits intrastate shipment of regulated material or commodities that test positive for *C. fimbriata* from a Rapid Ohia Death infested area to a non-infested island unless an effective treatment is available, is approved by the Department's Plant Quarantine Branch (PQB) chief, and the shipment has undergone the approved treatment; (3) exempts from the permit requirement certain finished ohia wood products, such as wood flooring and furniture that have been subjected to a treatment approved by the PQB chief; and (4) authorizes the PQB chief to approve treatments and mitigative measures as they are scientifically validated, and to revise permit conditions accordingly, as necessary to prevent movement of Ohia Wilt disease from the infested area and to preserve the quarantine.
