HAWAII 2021 VEGETABLE CROP VALUE AT \$64.9 MILLION

The farm gate value for Hawaii's vegetable and melon crops is estimated at \$64.9 million in 2021, up 30 percent from 2020 and up 19 percent from 2019. Cumulative production for vegetables and melons was 45.2 million pounds, up 18 percent from last year's 38.4 million pounds and up slightly from 2019. Area harvested at 5,100 acres in 2021 was up 19 percent from last year, but down 1 percent from 2019.

The top volume-producing published vegetable crop during 2020 was sweet potatoes, whose estimated production was 3.21 million pounds. Chinese cabbage was the second largest published vegetable volume crop, estimated at 2.90 million pounds. The leading farm gate published value was leaf lettuce, estimated at \$3.55 million. The second largest published value was Chinese cabbage, at \$3.23 million.
