To import swine into Hawaii, the following requirements shall be met prior to entry. Swine <u>not meeting pre-entry</u> requirements may be refused entry into the state and returned to their point of origin at the importer's expense.

Pre-shipment requirements for Swine Entering the State of Hawaii

- 1. Animals must originate from a herd that is **not under quarantine for any reason**.
- 2. Animals must be free of external parasites and symptoms of transmissible diseases and have not had recent exposure to these diseases.
- 3. Swine entering the state must be identified to meet USDA requirements for interstate movement. (https://www.aphis.usda.gov/traceability/downloads/rule_movement_swine.pdf. Swine for immediate slaughter must have an individual ear tag, slap brand, or tattoo. Breeding, feeder, or pet swine must have identification which meets the USDA requirements for interstate transport. Companion potbellied and mini pigs can be alternatively identified with unique microchips that are ISO 11784/85 compliant.
- 4. All swine must have negative fecal PCR tests for Porcine Epidemic Virus (PEDv) and Porcine Delta Coronavirus (PDCoV). Samples for testing should be collected 10 days or less prior to shipment.
- 5. Swine (except for those going DIRECTLY to slaughter) must have a negative Pseudorabies (PRV) serologic test within 30 days of the shipment by a USDA approved laboratory and the official ID should be listed on the laboratory report.
- 6. Swine moving to the island of Kauai must additionally test negative for PRRS within 30 days of shipment, and the animal's official ID must be present on the laboratory report.
- 7. A Certificate of Veterinary Inspection (CVI) from a licensed, accredited veterinarian, is required to be issued 7 days or less prior to shipment.

a) Required items on the CVI

- i. Issue date, all official identifications, and descriptions (age, breed, color, sex, and other unique identifying features)
- ii. The negative test results for all required pre-entry tests, along with the testing laboratory and the date the testing was performed.
- iii. The following statements:
 - 1. Swine are free from external parasites and symptoms of transmissible diseases and have not had recent exposure to these diseases.
 - 2. Swine have originated in a herd in which there have been no cases of pseudorabies during the twelve-month period preceding the shipment.
 - 3. Swine have not been exposed to feral swine.
 - 4. Swine have not been fed raw garbage.
 - 5. Swine are progeny of and originate in a herd and area not under quarantine for any other swine disease.
 - 6. The following statement is to appear on the CVI for all livestock entering Hawaii originating from states affected with Vesicular Stomatitis for the duration of the VS outbreaks:

"I have examined all the animals identified on this certificate within 72 hours of shipment date and found them to be free from signs of Vesicular Stomatitis (VS). During the last thirty (30) days, these animals have not been exposed to VS nor located on a VS confirmed or a VS suspected premises."

- b) Required items to be attached to the CVI
 - i. Official test charts for all required pre-entry testing should be attached to the CVI.
- 8. *UPDATE* Request a Swine Import Permit from the Animal Industry Division when copies of the CVI and official test charts are available for review. Once pre-shipment requirements are met, a Swine Import Permit will be issued. The import permit and CVI must accompany the shipment. Documents will be reviewed and permits will be issued daily during business hours. To request an import permit, contact the Animal Industry Division:

It is the responsibility of the owner or authorized agent of the owner to present a **COMPLETE**, **LEGIBLE**, **ORIGINAL** hardcopy of the CVI which meets the State of Hawaii's pre-shipment requirements at entry inspection.

Post-arrival requirements for Swine arriving in Hawaii

- 1. Swine imported for slaughter shall be consigned to the licensed quarantine slaughterhouse designated on the swine import permit, and should be slaughtered within 30 days.
- 2. Feeder and breeding swine shall be isolated at the farm designated on the swine import permit and be tested for brucellosis and pseudorabies 30 45 days after arrival.
- 3. Pet swine which will never contact other swine do not require post-arrival testing.
