Repeal of Chapter 4-96 and Adoption of Chapter 4-96.1 Hawaii Administrative Rules

SUMMARY

- 1. Chapter 4-96, Hawaii Administrative Rules, entitled "Schedule and Fees for Licensing Devices Susceptible of Commercial Usage, and Measuring Devices and Measurement Standards for Testing or Certification," is repealed.
- 2. Chapter 4-96.1, Hawaii Administrative Rules, entitled "Schedule and Fees for Licensing Devices Susceptible of Commercial Usage, and Measuring Devices and Measurement Standards for Testing or Certification," is adopted.

§4-96.1-1 <u>Severability</u>. If any provision of this chapter is held invalid, the invalidity shall not affect the remainder of this chapter and, to this end, the

provisions of this chapter are severable. [Eff APR 2 5 2009] (Auth: HRS §486-7) (Imp: HRS §486-7)

§4-96.1-2 <u>Violation</u>. Any person omitting the required acts or committing the proscribed acts, or failing to pay the fees as established herein shall be in violation of this chapter and subject to the provisions of chapter 486 Hawaii Revised Statutes. [Eff APR 2 5 2009] (Auth: HRS §486-7) (Imp: HRS §486-7)

§4-96.1-3 <u>Applicability</u>. This chapter shall apply to all weighing and measuring devices engaged in or susceptible of commercial usage. [Eff APR 2 5 7009] (Auth: HRS §486-7) (Imp: HRS §486-7)

§4-96.1-4 Definitions. As used in this chapter,

"Accurate" means the performance or value (the indications, deliveries, recorded representations, or capacity or actual value, etc., as determined by tests conducted according to suitable standards) of a piece of equipment conforms to the standard within the applicable tolerances and other performance requirements. Equipment that fails so to conform is considered to be inaccurate.

"Administrator" means the administering officer of the quality assurance division, or any qualified person so designated by the chairperson of the board of agriculture.

"Certification fee" means the charge for testing for the certification of measuring devices or measurement standards.

"Commercial usage" means persons, things, and actions, including governmental agencies, involved in establishing the net, gross, or tare measure, cost, or value of any part, portion, or proration of the total, as it may be used in the quantification or measurement of anything impacting upon salary or wages, commerce or trade, or its documentation, including the establishing of taxes due.

"Correctness" means a piece of equipment is considered to be correct when, in addition to being accurate, the piece of equipment meets all applicable specifications, tolerances, and other technical requirements. "License fee" means a fixed charge for permission granted by the administrator authorizing usage of a device susceptible of commercial usage.

"Suitability" means a measurement standard, which has been submitted to and approved by the administrator as to correctness and type for its intended use.

"Testing fee" means the charge for services rendered, by the administrator, for testing measuring devices or measurement standards on a request basis.

- §4-96.1-5 <u>Commercial usage device annual license required.</u> (a) Prior to the use of any device susceptible of commercial usage, an annual license fee shall be paid as prescribed in Table I entitled "Schedule of Annual License Fees", dated November 25, 2008, and located at the end of this chapter.
- (b) The license fee, payable to the state director of finance by check, cash, or money order, shall be mailed or delivered to the administrator as scheduled in this section. When available, payment may be made by credit card or electronic fund transfer.
 - (1) Scales and linear measuring devices (except taximeters):
 - (A) License fees shall be due and payable February 1; and
 - (B) Licenses shall be valid from February 1 to January 31 of the following year;
 - (2) Taximeters:
 - (A) License fees shall be due and payable June 1; and
 - (B) Licenses shall be valid from June 1 to May 31 of the following year;
 - (3) Volumetric meters and dispensers:
 - (A) License fees shall be due and payable September 1; and
 - (B) Licenses shall be valid from September 1 to August 31 of the following year; and
 - (4) All other non-categorized measurement standards:
 - (A) License fees shall be due and payable October 1; and
 - (B) Licenses shall be valid from October 1 to September 30 of the following year.
- (c) The license fee shall be due immediately for any measuring device placed in service after the due date and the license shall be valid to its respective termination date stated in this section. [Eff APR 2 5 2009] (Auth: HRS §486-7) (Imp: HRS §486-7)

- §4-96.1-6 <u>License renewal.</u> (a) Any measuring device engaged in or susceptible of commercial usage shall be licensed for the year of potential use. The license fee shall become due and payable as scheduled in section 4-96.1-5.
- (b) The use of any measuring device, not licensed as required in this chapter, is prohibited.
- (c) Any license issued under this chapter shall not be transferred from one device to another. This shall not preclude the transfer of the title of a measuring device, along with its current license, to another person, provided the complete device is transferred. - $\S4-96.1-7$ <u>License application form.</u> The measurement standards application for licensing a commercial measuring device may be obtained from the administrator upon request. [Eff APR 2 5 2009] (Auth: HRS $\S486-7$)
- §4-96.1-8 <u>Fee responsibility</u>. The payment of a license fee shall be the responsibility of the person deriving the direct economic benefit from the use of the device. [Eff APR $2.5\,2009$] (Auth: HRS §486-7) (Imp: HRS §486-7)
- §4-96.1-9 <u>Certification of measurement standards; fee.</u> (a) A measurement standard, used in proving the correctness of equipment engaged in or susceptible of commercial usage, shall be submitted annually to the administrator for examination as to suitability.
- (b) Certification fees shall be paid according to Table 2 entitled "Schedule of Calibration Fees", dated November 25, 2008, and located at the end of this chapter. [Eff APR 2 5 2009] (Auth: HRS §486-7) (Imp: HRS §486-7)

- §4-96.1-10 <u>Special test request; fee.</u> The fee for a requested special test shall be \$500 except if:
 - (1) The requested special test requires the use of the test-weight truck, the fee shall be \$750;
 - (2) The requested special test requires the use of the one-thousand-gallon petroleum test equipment, the fee shall be \$750. [Eff APR 2 5 2009] (Auth: HRS §486-7) (Imp: HRS §486-7)
- §4-96.1-11 Returned-check charge. When the payment of any fee established in this chapter is made by check, a charge of \$\(\frac{25.00}{25.00} \) shall be assessed, in addition to the amount of the fee, if the check is not honored due to insufficient funds. [Eff APR 2 5 2009] (Auth: HRS §486-7) (Imp: HRS §486-7)
- $\S4-96.1-12$ Exemptions. The administrator may exempt a device or class of devices from the fee requirements of this chapter when the exemption is in the public interest. [Eff APR 2 5 2009] (Auth: HRS $\S486-7$) (Imp: HRS $\S486-7$)

The repeal of Chapter 4-96 and the adoption of chapter 4-96.1, Hawaii Administrative Rules, on the Summary Page dated November 25, 2008, were adopted on November 25, 2008 following public hearings held on Oahu; Kauai and Maui; Kona and Hilo; respectively, on October 28, 24, 23, 22, and 21, 2008, after public notice was given, respectively, in The Honolulu Star Bulletin, The Garden Island newspaper, Maui News, the West Hawaii Today, and the Hawaii Tribune-Herald newspapers on Sunday September 21, 2008.

The repeal of chapter 4-96 and the adoption of chapter 4-96.1 shall take effect ten days after filing with the Office of the Lieutenant Governor.
