  - A. Status of 2023 Proposed Irrigation Water Rate Changes
    - a. Still in evaluation phase
  - B. Letter to Board of Agriculture addressing concerns over funding of the MIS
    - a. MIS currently has no federal funding
    - b. No letter was presented at this time
- 5. New Business
  - A. Pump Data and Electric Use Discussion
    - a. MIS utilized 5 groundwater pumps, 1 runs 24 hours a day, 1 runs for 4 hours at night.
    - b. Pump 5 and 6 were alternating, but at the advice of Kirk switched to running one at a time so that they would wear evenly but at different times in case of failure of one, the other should be good.
    - c. There are surcharges that can be added according to irrigation system rules
      - i. If the system usage is greater than 850 million gallons, a 5cent (per thousand gallons) discount can go to users of that irrigation system
      - ii. If the pumps run 4 or more cumulative months, a 5 cent (per thousand gallons) surcharge can be added to users of that irrigation system
      - iii. The rate table for current rates goes up to 2011. The rules also state that there can be up to a 2 cent (per thousand gallons) increase per vear.
      - iv. No discounts, surcharges or increases were issued in the last year
