 - A. System update refer to attachment, board asked for amendment of report for interruption of service for meters under service and laterals that will no longer be a part of the meter project.
 - B. Capital Improvement:
 - 1. Waikolu Valley fiberglass walkway project. Tentative July start date
 - 2. Water valve replacement by Goodfellow Bros. Project is in progress. Replacements are requiring a disruption in service, but only a few hours, Lance is notifying customers beforehand. The handful (#?) of laterals that also need to be repaired which were assumed to be part of this project have been put on hold as the contractor has said that additional permitting would be required, grading permit and historical survey. The board questioned this, knowing of the agricultural exemption to grading and grubbing permits, especially relating to maintenance of existing irrigation infrastructure. HDOA will be following up by next meeting.
