- 3. Approval of minutes: Minutes were not approved because although the board had quorum, no one was present to second the motion for approval as only fully confirmed board members are allowed to vote.
- 4. Old Business:
 - a. Proposed Water Rate Changes
 - i. Public testimony was received. The department of Agriculture is going through the testimony, but it hasn't gone to the board yet. They are also concurrently reaching out to legislature to look for alternative means of funding. There is no new timeline on next steps.
 - ii. The MISUAB has decided that we would like to place our own letter to the editor in the Molokai Dispatch stating that we oppose the rate increase on the basis that we disagree with the results of the financial analysis. We completely agree that the MIS needs funding for projects, infrastructure and salaries, but we do not feel the rate increase is the best way to cover these expenses.

 - i. The board discussed the option for online payments.
 - ii. Pumping system improvement project.
 - iii. Would like to see the rest of the valves from the meter replacement project completed along with any corresponding studies and permits with the State historic preservation department regulations.
 - iv. Replace the rest of the leaking couplings on the transmission line.
 - v. Request for information on how to close an account to avoid paying an acreage assessment fee if no water is being drawn.
 - vi. Communications into the valley, Hawaii Tel line to be fixed so phone can work again.
 - vii. New mower or better, tractor with arm mower to do brush control on the sides of the reservoir.
 - viii. Solar project, help with the system losses to minimize evaporation.

B. Capital Improvement:

- 1. Waikolu Valley fiberglass walkway project. Prometheus work is in progress
- 2. Water valve replacement by Goodfellow Bros. Project is almost complete, but some valves need to be moved to a new CIP because they are stuck and need to be dug out which may require a permit.
- 3. Corona Virus Recovery Funding
 - a. Repairs to sluice gate and lower diversion dam, waiting on parts.
 - b. Replace couplings on transmission pipeline, but there is not enough funding for this, so only some of the couplings can be replaced, not all.
 - c. Replace broken gates
 - d. Kualapu'u reservoir, contractor to remove vegetation.

- D. Board Member Vacancies
 - a. All vacancies have been filled, waiting on confirmations.
