The Board, at the August 24, 2019 meeting, deferred this Board Report and requested the Agricultural Resources Management Division submit an economic impact study at a later meeting. The economic impact study is an attachment to this Board Report.

Chapter 4-157-21 of the Hawaii Administrative Rules (HAR) allows the Board to establish irrigation system rates and charges. The last time irrigation system rates and charges were established by the Board was during the fiscal year (FY) period of 2006 to 2011, when water toll charges were increased from \$0.32/1,000 gallons to \$0.50/1,000 gallons.

Hawaii Revised Statues (HRS) 167-22 requires the Hawaii Department of Agriculture (Department) to establish an irrigation system revolving fund. The irrigation system revolving fund should be self-sufficient and is supported by revenue from water delivery fees, acreage assessments, and legislative appropriations.

Currently, the irrigation system revolving fund is not self-sufficient. The irrigation system revolving fund is subsidized by the general fund and barrel tax fund. These funds, which contain a portion of the irrigation system's labor costs, allow the Department to keep the irrigation system rates and charges low but does not fulfill the requirements of HRS 167-22.

This Board Report request preliminary approval to revise HAR 4-157-21 to establish new irrigation system rates and charges and public hearings to bring the Department in compliance with HRS 167-22.

- HAR §4-143-6(e) Hawaii prime green coffee consists of Hawaii beans which do not exceed 20% defective beans by weight. The defect tolerance of 20% shall be in effect until June 30, 2020. Beginning July 1, 2020, the defect tolerance shall be 15%.
- HAR §4-143-6(i) A bean that is affected by not more than 2 pinholes caused by insect damage regardless of discoloration associated with the insect damage shall be scored at 1/10 of a full imperfection. The defect tolerance of 1/10 of a full imperfection of not more than 2 pinholes caused by insect damage regardless of discoloration associated with the insect damage shall be in effect until June 30, 2020. Beginning July 1, 2020, the defect tolerance shall be 1/5 of a full imperfection.
- HAR §4-143-11(a) Hawaii natural prime coffee consists of Hawaii beans which do not exceed 20% defective beans by weight. The defect tolerance of 20% shall be in effect until June 30, 2020. Beginning July 1, 2020, the defect tolerance shall be 15%.
- HAR §4-143-12(a) Hawaii mixed natural prime coffee consists of a combination of Hawaii green coffee beans and Hawaii natural coffee beans which do not exceed 20% defective beans by weight. The defect tolerance of 20% shall be in effect until June 30, 2020. Beginning July 1, 2020, the defect tolerance shall be 15%.
