Farm Labor Statistics State of Hawaii, Second Half 2022

Hawaii's hired agricultural workforce increased to 6,000 in the fourth quarter of the calendar year, 2022.¹ The number of hours worked in the two reference weeks declined by 7% when compared to corresponding periods in the previous year. However, the gross wage rate paid to hired workers increased marginally to a high of \$19.53 per hour during the week of October 9-15, 2022.

Hawaii agribusinesses hired 268 guest workers on H-2A visas at the end of September 30, 2022, 27% higher compared to the same period in the previous year. The gross wage rate at the high-end range paid to guest workers was \$2.99 an hour lower than that for all hired farm workers.² The distribution for H-2A workers employed locally by agricultural classification were as follows: coffee (80), apiculture (21), livestock (11), general farm workers (155) and administrative support (1).
