HAWAII 2022 VEGETABLE CROP VALUE AT \$73.0 MILLION

The farm gate value for Hawaii's vegetable and melon crops is estimated at \$73.0 million in 2022, up 13 percent from 2021 and up 47 percent from 2020. Cumulative production for vegetables and melons was 44.9 million pounds, down nearly 1 percent from last year's 45.2 million pounds, but up 17 percent from 2020. Area harvested at 5,215 acres in 2022 was up 2 percent from last year and 21 percent from 2020.

The top volume-producing published vegetable crop during 2022 was sweet potatoes, whose estimated production was 2.50 million pounds. Chinese cabbage was the second largest published vegetable volume crop, estimated at 2.32 million pounds. The leading farm gate published value was head lettuce, estimated at \$4.40 million. The second largest published value was green onions, at \$3.93 million.
