RE: Testimony in Support of Milton Coleman, Jr. regarding Agenda Item IV. B2. Request to TerminateGeneral Lease No. S-3109, Milton Coleman, Jr. Lessee, TMK (1) 4-1-018:048, Koʻolaupoko, Waimanalo, Island of Oahu, Hawaii

Aloha Chairperson Hurd and members of the Board,

Our organnization submits this testimony in support of Mr. Coleman and in strong **opposition** to the staff's recommendation to cancel the lease. Our organization has partnered with Mr. Coleman through his Pahonu Wa'a 'Ohana organization to support a Hawaiian cance sailing program. The staff submittal states that the current lease rent is \$12,340.00 per year and notes that this year alone, the family paid \$19,600.00 towards the lease rents. In other words, in this year alone, the family paid for nearly a year and a half of payments. It is our understanding that a substantial payment was made last year as well. Given the good faith effort of the 'ohana to demonstrate an intent to bring their account current, this Board should inquire and consider what kind of realistic repayment plan was considered or offered before resorting to the drastic step of lease cancellation and removing this longstanding Waimanalo family from the 'āina.

Ko'ihonua, is a non-profit dedicated to reclaiming and providing cultural space for our lāhui to learn, practice and engage in Hawaiian traditions and practices. Our mission is to reclaim and restore Hawaiian lands and provide the means and resources for Hawaiians to engage in traditional practices by creating Hawaiian cultural space. We are currently in partnership with Kumuhau Farm and the Pāhonu Wa'a 'Ohana, both of which are run by Mr. Coleman and his 'ohana. The program is dependent on access to the lease parcel in Waimanalo currently subject to termination.

Ko'ihonua has participated in an agroforestry cohort with Kumuhau Farm for two years under the guidance and mentorship of Dr. Craig Elevitch through Ke Kula Nui o Waimanalo. During that time, Mr. Coleman and his 'ohana have participated as an

active partner, working to reestablish native and food plants on the leased property. Their 'Ohana is an active contributor to the cohort and the Waimanalo community.

Our organization also partners with Pāhonua Wa'a 'Ohana through the use of a large scale sailing wa'a used for community educational programming. Ko'ihonua is looking forward to future partnership and collaboration with Kumuhau Farm and Pahonu Wa'a.

The value of maintaining an 'ohana with generational roots in the local community and committed to land stewardship is priceless. We request that you consider the substantial payments already made this year and extend further consideration to the Coleman 'ohana in light of their deep commitment to the Waimanalo community.

Aloha Board Members,

My name is Dr. Samantha Keaulana-Scott and I am writing to STRONGLY SUPPORT Milton Coleman, Jr.'s and ohana's request in keeping General Lease No. 3109. I am a professor and health disparities researcher, but I write you today as a concerned, Native Hawaiian. My work unpacks how inequities, like LACK OF ACCESS TO LAND, in society impacts Native Hawaiian Health.

Since receiving this parcel of land, 'Ohana Coleman has worked tirelessly to support the Waimānalo community and MANY others across Hawai'i with their sustainable living, growing of food, and offering programs that IMPROVE Native Hawaiian health. The land has fed many of us and provided a place of healing, community connection, and (re)connection to land and identity (all of which contribute LARGELY to Native Hawaiian mental, physical, emotional, and spiritual health). They established a food forest with many native plants, fruit trees, sweet patoto and more to echo a natural forest which will support the environment and grow agriculture in a sustainable way. The food forest has since fed 'Ohana Coleman and the community in Waimānalo. 'Ohana Coleman has also received various grants to establish working groups on the leased land. Some of those working groups are for youth who will get to work on the land and build youth leadership and a skillset in land health and growing food that will feed generations to come.

We know that COVID-19 has had a detrimental impact on our Hawaiian families. In a recent study conducted, over 300 Native Hawaiians were surveyed, and many were from Waimānalo. The data demonstrated that 31% and 42% of Native Hawaiians suffered from depression and PTSD respectively during the pandemic. Furthermore, 33% and 20% suffered from low food security and very low food security respectively. A moratorium on rent was not enough for most families. Many were and are still hungry on top of dealing with stress and other burdens.

Your board has the opportunity to demonstrate that you care about Hawaiian health, the future of Waimānalo, and Hawaiian families that were largely impacted by the financial and social consequences of the pandemic. To strip 'Ohana Coleman of their lease is to strip them of their health and well being, our health and well being, and the community's health and well being. Sustainable, healthy living STARTS WITH FAMILIES like 'Ohana Coleman who have dedicated their lives to helping others live sustainably.

Please join us in supporting this amazing family.

Junior Coleman and his family have participated in our programs at the Waimānalo Research Station for several years, including aquaponics and agroforestry programs aimed at providing Native Hawaiians food production training.

I just had a meeting with Junior Coleman on Saipan where I am presenting a series of ecological farming workshops with the CNMI Division of Agriculture. He made me aware of the recent progress being made on paying what's owed on the lease and the plans to continue to increase production and profits on the farm. As a CTAHR extension specialist in sustainable and organic farming systems, I fully recognize the importance of keeping our agricultural lands productive and profitable. I will be visiting the farm when I return to O'ahu to review the plan and make suggestions on how to increase and sustain the farm's productivity and viability.

Furthermore , utilizing available invasive trees such as African tulip,Java Plum, Fern tree for the production of canoe model kits and Waimanalo wood furniture will commence.

A second business endeavor involves an innovative concept creating a 'living off the land scape' venture where potential clients and customers visit the farm free of charge to take a look at different models of food and medicinal plant landscapes including canoe plants, endemic species, citruses, staple starches, and aesthetic Hydroponic systems etc. Personalized family food systems can be installed at their residences, businesses or estates.

The third tier will include a proactive approach to harvesting and processing various plants including Uhaloa(Waltheria indica), Malunguy(Moringa Oleifera), Olena (tumeric), Nioi, Mamaki etc. for teas and high potency juice extracts. Additionally, harvesting and processing of the abundant Java Plum trees by using the fruit, seeds and leaves for it's beneficial health properties, also using excess wood for carving products and firewood products as well.

Fourth income producing venue comes by way of various plant and flower (lei) groves namely ti, puakenikeni, plumeria, pakalana, and pikake which will continue to be cultivated for their respective viable purpose.

The timeline to have each agri-business venture aforementioned to be at optimal operation and revenue generating is over the course of 2-3 years. Agricultural/Cultural products and services will be marketed via social media platforms, internet, open markets, conferences, conventions, news, school systems, hotel shops, media, etc.
