# IN RESPONSE TO ACT 222, SESSION LAWS OF HAWAII 2022 REQUIRING THE DEPARTMENT OF AGRICULTURE TO SUBMIT A REPORT ON THE ECONOMIC STUDY ON CHANGES IN COFFEE LABELING LAW

### **Background**

Act 222, Session Laws of Hawaii 2022 was enacted to support Hawaii's coffee growers by appropriating funds to Hawaii Department of Agriculture (HDOA) to conduct an independent study to assess the economic impact of Hawaii's coffee labeling laws on local coffee farmers and the local coffee industry. HDOA was mandated to complete the study no later than January 1, 2024, and submit a report of its findings and recommendations, including any proposed legislation, to the legislature no later than twenty days prior to the convening of the regular session of 2024. Since HDOA does not have the expertise, an RFP procurement process was used to select an economist/consultant to carry out this independent study. Guild Consulting was selected as the contractor and a contract in the amount of \$89,694.00 was fully executed on June 23, 2023 with scope of work and deliverables listed in the next section.

#### **Scope of Work and Deliverables**

- Conduct and prepare an economic impact study on the local coffee industry and stakeholders concentrating on the Big Island of Hawaii's Kona and Kau geographic regions including a focus group assessment to address the impact on consumers.
- Consult with coffee farmers, including the Hawaii Coffee Association, Kona Coffee
  Farmer's Association and other stakeholders in the coffee industry such as roasters and
  distributors for purposes of conducting the study.
- Analyze impacts from the perspective of Hawaii coffee industry stakeholders located within the physical boundaries of the State.
- Include relevant literature review on the economic effects of labeling requirements.
- Based on available data:
  - Make projections of sales demand and changes in pricing based on proposed changes in the labeling requirements from 10% local geographic blends currently to 20%, 30% and 51% within a 3 year phase in period.
  - O Use current data of 100% regional coffee production and projections of costs and volume after changing the current blends to 51% from 10% and how the 10% to 51% changes affect the impact on 100% geographic product.
  - Examine current market share between Kona and Kau coffees initially and how
    that share may change over the phase in period with possible policy
    recommendations (e.g. 3 years) to mitigate any shocks to the industry because of
    increases to minimum blend requirements.
  - Estimate changes in production showing projections of producer surplus,
     inventories or depletion, shortages and losses of product due to the changes in

- demand based on pricing, and other economic and environmental factors from each scenario listed in RFP-05203-QAD.
- Show and quantify with graphics and numerical statistics (where available) supply and demand curve changes for each scenario listed in RFP-052023-QAD.
- O Show the potential changes of equity and fairness within the industry with social and economic changes resulting in access for product and consumption access.
- o Map current sales and future sales volume and income of each coffee chain product such as cherry, parchment, green and roasted coffee.
- Evaluate possible overall industry income expansion or contraction with each blend ratio change.
- o Estimate increases or decreases in total State tax revenues from all sources.
- o Examine employment fluctuation expectations at each level in the coffee industry.
- Should pertinent data be unavailable after exhausting all sources, upon agreement with the State, Contractor shall provide theoretical projections and estimates, based on sound-economic reasoning and cited sources.
- Analyze, based on available data, and theorize changes in market efficiencies including redistribution and changes within the industry stakeholders, including changes across the supply chain, of who potentially benefits are and who potentially loses market share and income among growers, blenders, distributors and retailers.
- Complete the study no later than December 29, 2023 and have materials ready to present with recommendations and findings, including any proposed legislation.

### **Final Results and Recommendations**

A final report of findings and recommendations including any proposed legislation will be available and provided to Legislature after the completion of the study on December 29, 2023.
