2 3 4 5	 Request that One (1) loan to Island Manaia, LLC be referred to the Attorney General's Office for disposition and collection.
5 6 7	Yong Pak, Agricultural Loan Division, presented testimony as submitted.
, 8 9	Motion to Approve: Gomes/Ley
10 11 12	Discussion: Member Oswald asked if the last contact was July of 2024?
13 14	Mr. Pak said it was June of 2023.
15 16	Member Oswald asked if there was any conversation about their plans?
17 18 19 20	Mr. Pak said he wanted to meet and talk to them, but they did not want to cooperate. Mr. Pak was trying to find an address to send correspondence, and they provided a P.O. Box, but he is unsure if this is correct.
20 21 22 23	Member Oswald asked if they are aware of the outstanding balance and that this needs to be collected.
24 25	Mr. Pak said yes, they are.
26 27 28	Member Ley said a situation like this is rough and she would like to ask for consideration on that.
29 30	Member Gomes asked how the correspondence is sent.
31 32 33	Mr. Pak said he scans the correspondence and sends it via email along with a mailed copy. Mr. Pak said he gets a response via email.
34 35	Member Gomes asked Mr. Pak if he's ever seen the property.
36 37 38	Mr. Pak said yes, he had and that when he went out to the property, there were workers who were cleaning out the place. There is a dwelling there.
39 40 41 42	Member Gomes asked if the board could get some pictures so he could see the situation and how bad it is. He asked if the property would come up again for lease once the AG has it.

1 2	Mr. Pak said this is a private lease and not state land. He added that the truck wasn't there which was probably the most valuable so he assumes they disposed of it.

14 15 16	Member Gomes said this operation has been very successful and they are very good stewards of the 'aina. Do we know if there are any succession or children that would take over?
17 18 19 20	Ms. Scheibe said the individual is a parent, but she doesn't know what their thoughts are.
21 22 23 24 25	Member Oswald asked if there is any available market research with this expansion and if the market can absorb it and remain profitable? He said he's assuming they're selling everything they make. He also asked if there are any projections that they might overproduce and soften the market?
26 27 28 29 30 31	Ms. Scheibe said they were able to attend the Hawaii Impact Ready cohort, where they did a lot of business strategy over 2024, and part of what that was seeing how that ramp up strategy would play out. Their markets are currently asking for about a quarter more than they're providing. They could scale back purchasing from other farmers if they saturate the market.

19 20 21 22	Discussion: Member Ley said she doesn't see the role that DLNR plays in this and if this is an oversight or whether they don't need to be included.
23 24 25 26	Member Kanaka'ole said there are three entities that are doing the acquisition – DOA, ADC, and DLNR. He said the MOA and board action will allow DOA and ADC to move forward on doing the acquisitions and closing on their portions of the bigger project. DLNR is still undergoing the due diligence process.

39 40 41 42	Discussion: Member Gomes asked if there is a timeframe that he needs to complete the fence? Are there any stipulations?

1 Ms. Ah Yo said the loan side may have but we don't. Within the 1st year of having the lease, he needed to provide the receipts to get the offset which he did, and it far 2 3 exceeds. 4 5 Ms. Ah Yo said to her knowledge, the lease is general, and it doesn't have a specific height for the fencing, and she'll need to double check. If the loan requires it, it would be 6 7 stipulated. 8 9 Member Gomes asked if they need to provide some pictures or updates of what they've been doing? 10 11 12 Ms. Ah Yo said yes for the rental offset. She added that they do at least 1-2 inspections 13 throughout the year so they would see their progress. 5 6 7 8	Brandi Ah Yo, Agricultural Resource Management Division, presented testimony as submitted.
9 10	Motion to Approve: Gomes/Kanaka'ole
11 12 13 14	Discussion: Member Oswald said he feels that this is moving in the right direction of doing what is right.
15 16 17	Member Ley asked if the character of use being proposed as pasture excludes any renting of the stables and rodeo activities?
18 19 20	Ms. Ah Yo said correct, no rodeo activities. She said if the stables are utilized to house the cattle, she believes that would be ok, but she will need to double check on that.
20 21 22	Member Ley asked if it would be the Gibson's cattle and not external parties.
23 24	Ms. Ah Yo said that is correct.
25 26 27 28	Member Ley said that on the second page of this submittal it refers to the board having the power to waive rental payments due to natural catastrophes or other external factors beyond the lessee's control. She said she assumes this is a situation where it's beyond the lessee's control. She asked what the situation is that drove this backlog of rent.
29 30 31 32	Ms. Ah Yo said that would be a question for the lessee and that she does not have any more information.
33 34 35 36 37	Member Ley said as board members, we want to relieve them of the financial strain that the lease may be putting them under, but we also have fiduciary responsibility with state assets. She said this is why she is looking for a statement about what is driving this waiver of the back rent.
38 39 40 41 42 43	Member Cabral said the transfer was done in 2017 and if we follow logic, it should have been handled in 2017. Based on Act 90 and the transfer, it was transferred by EO but it was never agreed upon by DOA. There's some stuff that was in limbo and if this was done in 2017, we wouldn't be in this situation today. It would have been at a reduced rent. This is an old quarry site that has been there since the 1960s. He added that the work that he put into that place is amazing. He said Mr. Gibson provides a strategic

- 1 opportunity for the community by holding rodeos and other stuff. He adds that he thinks 2 it's very reasonable to forgive the lease rent. 3 4 Member Cabral said to his understanding, EPA never said that it is a large capacity 5 cesspool and that it just could be considered a large capacity cesspool. 6 7 Ms. Ah Yo said it is her understanding that it's implied that it is a large capacity cesspool. She said she believes there was further correspondence that confirmed it. 8 9 Mr. Buddy Gibson said it was never confirmed but because they were a business 10 agriculture, that is what caused them to be referred to as large because of their size. 11 12 13 Member Cabral said we need to keep in mind that the interpretation recently changed 14 because before then it wasn't an issue. He added that given the way EPA is going 15 under the new administration, it may change everything again. He said the interpretation 16 was changed with no public input at all, so it is guestionable if it's legal or not. 17 Member Ley said it's no reflection on the applicant but it's just for the record. 18 19 20 Member Oswald asked if the cesspool was installed prior to the lease? 21 22 Member Cabral said it was done in the 1950s by a prior lessee. 23 24 Mr. Gibson said it was built in 1949. 25 26 Member Oswald added for consideration that if we build these leases and we're making 27 them available for agriculture, partnership into improvements is important. 28 29 Member Gomes said he's known Mr. Gibson for a very long time. Mr. Gibson has taken a dump and made it into the best he can. He added that it is true that he supplies 30 240,000 pounds of beef but that may be only the processing, but he has other beef on 31 32 his property. He said there's a lot of us in the cattle industry that relies on Mr. Gibson. 33 34 Member Gomes said that if the ship breaks down or Matson changes the date for shipping the cattle, Mr. Gibson houses the cattle and horses, feeds and waters them, 35 36 and coordinates and reloads them back to get shipped where they need to be. Member Gomes said Mr. Gibson also deals with sheep, goats, llamas and a variety of livestock 37 38 that comes through his facility. Member Gomes said he sees things that need to be 39 changed but he'd like to see some consideration of the assets that he supplies to our industry throughout the 50th state. Mr. Gibson is an icon in the industry, and he's helped 40 41 us tremendously in Hawaii. He added that Mr. Gibson has never asked to be 42 compensated and it's always for the industry.

1 Member Gomes said that he remembers back in 2017 he was with the BLNR and made 2 the motion to take it over from DLNR and give it to DOA, so he is aware of the situation. 3 He added that the cesspool deal goes back to 1949, and it's been 75 years. He said he 4 thinks they just dug a hole, and they don't think they knew it was high capacity. 5 6 Member Gomes said we need to really take into consideration and if it can't be done, 7 we should change the statute, law, or requirements to accommodate that this is an 8 agricultural entity. This is a ranching stakeholder. He added that we need to help this 9 gentleman. 10 11 Member Cabral said it says no stabling of horses, so he is wondering if this is by statute 12 or another policy. 13 14 Ms. Ah Yo said the character of use is pasture. If it was different than pasture, it might 15 allow for other things. 16 17 Member Cabral said when he inquired about this previously, he was told that because the appraisal was done only on pasture, it came out differently. When the lease gets 18 19 negotiated between DOA and Mr. Gibson, is this something that can be worked out or is 20 it out of the picture? 21 22 Ms. Ah Yo said that it would be a legal question and if it would require a change in 23 character of use, there may be additional steps that would come to the table. She said 24 her understanding is that whenever there is a change of character of use, it would 25 require the cancellation of a lease which would then prevent the department from doing 26 a direct lease. She said it would have to go out for public notice and then bid it out to the 27 public. The character use now with DLNR is special equestrian and since that is not agriculture activity, rodeos would not be allowed because it's not producing agriculture. 28 29 She said she believes this is why they are moving forward with pasture which allows 30 some wiggle room. 31 32 Deputy Attorney General Waihee-Polk reminded everyone that the item on the agenda 33 was regarding conversion and if the lessee wants to work out other issues with the 34 department, this should not be done in an open meeting. 35 36 Vote: Approved; Unanimously 37 38 V. - 4 Discussion:

5 Mr. Ho said the Two Lined Spittle Bug RFP had closed and is for \$240,000. This would

- be for management of TLSB on the Big Island. They received 3 proposals, and they are
 working on the contract.
- 8

9 They just got the finalized contract for LFA control work for Rentakil Terminex. They're 10 working with Hawaii Ant Lab to have them trained on Kauai and Maui. They're also

- 11 working with Mayor Alameda from Hawaii Island and trying to figure out a way to use 12 those treatments for the ones who would benefit more from the treatment subsidy for
- 13 residential services, especially how widespread LFA is.

15 The Pesticide Diagnostics RFP closed last month and they're working on the contract.

- He also said they're still working on the \$800K Green Waste and working out somequirks.
- 17 18

19 Mr. Ho said there are a bunch of bills that affect biosecurity and the renaming of the department. HB427 enables biosecurity emergencies with approval from the Governor. 20 HB1100 adds transitional facilities so basically everything needs to be inspected and 21 22 there's going to be private inspectors. They're creating rapid response units. Both will 23 make the Act 231 positions permanent. SB 253 enables the department to inspect every 24 commodity and allows for inspections of the same goods interisland and changes the 25 penalties from criminal to civil. SB251 creates a placard program and would require 26 everyone to have a placard which would be similar to the DOH food establishment 27 program. SB562 creates a registry program for nurseries. The legislature initially had it only for plants, but clarification was needed so they included any agricultural production. 28 29 Fruits, vegetables, cut flowers, and foliage are all now included in this registration 30 program. There is no inspection built in so it's unusual enforcement structure. HB175 requires any owner or lessee to maintain property to prevent the proliferation of invasive 31 32 species. It doesn't define invasive species, and it talks about managing plants that are deemed invasive. He said DOA submitted testimony before it went to FIN and that they 33 34 are going to be working with the introducer to clarify what they're seeking to intend to 35 do. 36 37 Mr. Ho said there's a lot of other ones but they're not as broad reaching as these are to 38 ag in general.
